OFFICIAL RULES AND ENTRY FORM**

To enter, each participant must submit by mail a COLOR print photograph. The photograph **must be** attached to a completed Hodges Badge Company, Inc 2010 Catalog Cover Contest Official Entry Form. Completed entries will be accepted only if postmarked on or before **October 1st, 2009**.

1. By submitting an entry, each entrant represents and warrants that:

- (i) he or she is the **SOLE** copyright owner of the Photograph;
- (ii) the Photograph will not and does not violate the rights of any **THIRD PARTIES**;
- (iii) he or she has obtained and shall submit model releases of the subjects of the Photograph;
- (iii) he or she is over the age of majority and has the right to contract in their own name
- (iv) he or she must sign and submit a Release, Authorization and Agreement to transfer rights to use all or any portion of the Photograph, in perpetuity, worldwide without restrictions and a fee.

2. The photograph must clearly and conspicuously show a subject wearing a rosette or neck sash won by said subject and manufactured by Hodges Badge Company, Inc. When judging entries, the company looks for:

- A Hodges Badge Company, Inc. ribbon, rosette or sash must be visible in the photograph.
- Clarity, sharpness and color - we cannot reproduce a photograph that is not clear.
- The background - please be sure your photograph is in a nice setting and that legs, tree trunks or telephone poles are not sticking out of either the horse's or rider's body.
- Ability to see the person's face - if under a hat or helmet, please be sure that it is not creating a shadow over their eyes.

3. A participant may submit any number of entries. Please send them in the same envelope.

4. All photographs must be readily reproducible. No negatives will be accepted. Photographs submitted cannot be larger than 8-1/2" x 11" or smaller than 4" x 6".

5. Photographs may not be altered in any manner. No painting, airbrushing, color-enhancement, etc., physical alteration of the photograph will be grounds for elimination from the contest.

6. Photographs will be judged on suitability for use as a catalog cover, that is, the best combination of the subject and Hodges Badge Company, Inc. rosette, neck sash or other first place award, and setting. Hodges Badge Company, Inc. reserves the absolute right to make all final judgments regarding the winning photograph as well as those selected for honorable mention. All participants who enter the contest agree to waive any right of recourse over the outcome or the selection of photographs. All participants agree to sign release and consent forms for use of their photographs in the 2010 Hodges Badge Company, Inc. Equestrian Catalog.
